### Awareness Lecture entitled "Your Health is the Key to Your Beauty"



The PR & Administration Services Group, through the PR and Media Team, organised an awareness lecture entitled "Your Health is the Key to Your Beauty", on Tuesday, February 4, 2025, at the Company's auditorium. The lecture featured Dr. Amna Shaghouli, Consultant in Endocrinology and Obesity at Adan Hospital and B Clinic, and Dr. Salma Al-Hamad, Senior Consultant in Plastic and Reconstructive Surgery.

Dr. Amna Shaghouli opened the discussion by addressing weight-loss medications and presenting real-world data from patient case studies. She highlighted the global and local prevalence of diabetes linked to obesity and explained the pharmacodynamics of weightloss injections, noting that they influence satiety centres in the brain by up to 90%. She emphasized the importance of weight loss in improving long-term diabetes outcomes. Dr. Shaghouli also confirmed the effectiveness of

medications such as Ozempic and Rybelsus for weight management.

Dr. Salma Al-Hamad then discussed preventative measures in cosmetic surgery, and weight maintenance strategies, in addition to acquired diabetes, its causes, and how to eliminate it. She stressed that cosmetic procedures are not solely based on body mass index but rather on fat distribution and localisation.

On the sidelines of the event, the KOC's Ahmadi Hospital participated by offering free blood pressure and blood sugar testing. Several specialised cosmetic clinics also took part in the event.


# Signing of a Memorandum of Understanding Between KOTC and the Arab Academy for Science, Technology, and Maritime Transport

- Surah Al-Mujadila is the only chapter in the Quran where the name of Allah is mentioned in every verse.
